

Mennonite Properties in the Schwetz Region, West Prussia: 1788-1824

The 1789 Land Census¹ and the 1824 Land Census² provide the only information about Mennonite land holders in the region monitored by Marienwerder during this period. In 1798 an update was provided³, but it was imperfectly executed since some districts submitted information about new Mennonite land holders only, while others submitted details about changes of ownership among Mennonites. For this presentation I have extracted information from the Schwetz Land Office records titled “Domänen Rent Amt Schwetz; Die Wegen Mennonisten – Wesens verlangte Nachrichten”.⁴ Throughout the balance of this discussion I will reference this document simply as “Schwetz Book”.

1. Adalbert Goertz extracted information from this Schwetz Book for 1801.⁵
2. Esther Patkau and Glenn Penner transcribed and partially translated the 1810 Census.⁶
3. Villages included in the Schwetz Book were: Beckersitz, Brattwin, Dworzisko, Glugowko, Neunhuben, Niedwitz, Ostrower Kaempe, Przechowko, Deutsch Westphalen and Polnisch Westphalen. Two other villages (with landless residents) were mentioned in the censuses of 1810 and 1812: Przechowo (separate from, but neighboring, Przechowko) and Jungen. Nearby villages not included were Alt-Marsau, Deutsch-Konopat, Jeziorki, Nieder-Gruppe and Ober-Gruppe because they were in the Konitz district, not Schwetz.
4. The Schwetz Book is worth browsing because it contains a variety of other interesting material including the Edict of Friedrich Wilhelm II dated 30 July 1789 (027.jpg-033.jpg) and the Declaration of Friedrich Wilhelm III dated 17 December 1801 (106.jpg-111.jpg). Both documents placed restrictions on the land holdings of Mennonites which contributed to their migration out of West Prussia.

Many of the census entries in the Schwetz Book are accompanied with comments describing prior ownership of these properties. It was therefore possible to compile a reasonably accurate ownership history for each property by utilizing this information in concert with West Prussian Property (Blatt) Records⁷ which are available for some of the properties along with additional information found in the GRanDMA database. The family censuses of 1810 and 1812 were especially helpful for establishing connections between the property holders and their corresponding serial number(s) in the GRanDMA database.

In the accompanying spreadsheet I have compiled ownership history for each property which ranges, depending upon the property, from 1763 to 1842. The entries are listed alphabetically by village name and within each village by Property Number (in the column labeled Prpty #) . The Property Numbers I have utilized are in sequential order as presented in the 1789 Land Census (with the exception of Niedwitz which was acquired in 1797, and Dworzisko which was inexplicitly omitted in the 1789 Land Census - as compiled by Adalbert Goertz). In the course of this project it became clear that these Property Numbers did not always correspond with Blatt record numbers for each property. For instance, in the Przechowko Blatt records the Property Numbers were often stated to be in accordance with the *Praestation Tabellen* (Tax Tables) numbers, not the Blatt numbers. Throughout the Schwetz Book land areas were listed in Hufen, Morgen and quad Ruten in accordance with the Culmisch Morgen standard. In 1822 both Culmisch Morgen and Magdeburg Morgen were listed and in 1824 all land areas were listed in accordance with the

Magdeburg standard (without the use of Hufen). The Blatt records also began using the Magdeburg Morgen about 1822; with reference to the Culmisch standard as simply “*Groß Morgen*”.
