The Pavlodar Mennonite Settlement, located in north-east Kazakhstan (see [https://gameo.org/index.php?title=Pavlodar Mennonite Settlement \(Pavlodar Province, Kazakhstan\)](https://gameo.org/index.php?title=Pavlodar_Mennonite_Settlement_(Pavlodar_Province,_Kazakhstan))) was established in 1906 by Mennonites from various settlements in the Russian Empire. The settlement of Slavs, Germans, and Jews in Kazakhstan throughout the 19<sup>th</sup> century was an attempt by the Russian Empire to colonize the territory now known as Kazakhstan. The settlement of non-Kazakhs increased substantially in 1906 upon the completion of the Trans-Aral Railway from Orenburg to Tashkent. By 1925 the settlement had a population of 2,736. The following data is a list of Mennonites in the Pavlodar settlement who were arrested and executed during the Great Purge.

The Great Purge (also known as the Great Terror) of 1937–1938 was a brutal campaign of political repression in the Soviet Union led by Stalin. It marked the peak of his efforts to consolidate absolute power by eliminating perceived enemies within the Communist Party, military, and broader Soviet society. An estimated 700,000 to 1.2 million people were executed, with over a million more imprisoned or sent to Gulag labor camps. Fear and paranoia gripped the country, as ordinary citizens were encouraged to denounce each other.

Ethnic Germans in the Soviet Union, including Mennonites, faced severe repression as part of broader “national operations” that targeted minority groups suspected of disloyalty. Although many German-speaking communities had lived peacefully in the Russian Empire for generations, they were viewed with suspicion by Stalin's regime, especially as tensions with Nazi Germany grew.

In 1937, Stalin approved NKVD Order No. 00439, which specifically targeted ethnic Germans for alleged espionage and ties to Germany, despite a lack of evidence. Tens of

thousands were arrested; many were executed or sent to labor camps in Siberia and Central Asia. This ethnic repression dismantled the social fabric of German-Soviet life and spread fear throughout their communities. The purge marked a turning point in the fate of Mennonites and other German-speaking people in the USSR, transforming them from an accepted cultural minority into a persecuted and displaced population. Their suffering exemplifies how Stalin's regime fused paranoia, nationalism, and political terror, destroying entire communities based on ethnic identity rather than individual actions. For Soviet Germans, the Great Purge was not only a period of mass arrests and executions but the beginning of a prolonged cycle of displacement, discrimination, and cultural erasure that lasted well beyond Stalin's death.

This document was originally compiled by Viktor Petkau and published in Russian on the chortitza.org website. I translated it using Microsoft Word's translation tools and then edited the document to make sure that the spelling of names conformed to standard spellings and that geographical entities were identifiable. I also added GRanDMA numbers when individuals could be identified.

**Bergen Franz Jacob** (#1187567). Born in 1874 in the village of Konteniusfeld, Berdyansk district, Taurida province, German. Arrested on November 1, 1937, on the day of his arrest he was a collective farmer of the collective farm "Fort-Shrit" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 22, 1937. Shot on December 4, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of March 10, 1958.

**Bergen Jacob Jacob** (#1187576). Born in 1904 in the village of Lindenau, Berdyansk district, Taurida province, German. Arrested on September 1, 1937, on the day of his arrest he was a collective farmer of the collective farm "Fort-Shrit" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 22, 1937. Shot on December 4, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of March 10, 1958.

**Block Peter Nicholai**. Born in 1899 in the village of Kormka, Buzuluk district, Samara province, German. He was arrested on February 1, 1938, on the day of his arrest he was a worker of the state farm "Jolkuduk" of the Pavlodar region. Convicted by the troika of the NKVD in the East Kazakhstan region on February 15, 1938. Shot on March 6, 1938. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of February 15, 1957.

**Boldt Abram Abram** (#1145588). Born in 1893 in the village of Alexandropol, Bakhmut district, Yekaterinoslav province, German. He was arrested on November 2,

1937, on the day of his arrest he was a collective farmer of the collective farm "New Life" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 22, 1937. Shot on December 4, 1937. Rehabilitated by the conclusion of the Prosecutor's Office of the Pavlodar region of April 28, 1989.

**Boldt Heinrich Heinrich.** Born in 1886 in the village of Friedensruh (Malachovka), Berdyansk district, Taurida province, German. He was arrested on September 17, 1937, on the day of his arrest he was an accountant of the Tavolzhansky salt industry. Convicted by the troika of the NKVD in the East Kazakhstan region on November 20, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of October 22, 1955.

**Boldt Isaac Abram.** Born in 1895 in the village of Alexandropol, Bakhmut district, Yekaterinoslav province, German. He was arrested on October 10, 1937, on the day of his arrest he was an accountant of the Frunche collective farm in the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Boldt Jacob Abram.** Born in 1896 in the village of Alexandropol, Bakhmut district, Yekaterinoslav province, German. He was arrested on September 24, 1937, on the day of his arrest he was a planner of the Zurupinskij District Executive Committee. Convicted by the troika of the NKVD in the East Kazakhstan region on November 27, 1937. Shot on December 4, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of April 21, 1958.

**Dick Dietrich Dietrich.** Born in 1904 in the Lozovsky district, German. He was arrested on July 28, 1938, on the day of his arrest he was a blacksmith of the collective farm "Iskra" in the Zurupinskij district. Convicted by the troika of the NKVD in the Pavlodar region on October 3, 1938. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of October 20, 1988.

**Dick Johann Johann** (#1144818). Born in 1878 in the Berdyansk district of the Taurida province, German. He was arrested on September 2, 1937, on the day of his arrest he was a collective farmer of the collective farm "Iskra" of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 23, 1937. Shot on October 31, 1937. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of October 19, 1960.

**Dick Kornelius Peter** (#922636). Born in 1885 in the village of Temir-Bulat, Taurida province, German. He was arrested on November 9, 1941, on the day of his arrest he was an accountant of the collective farm "Proletariy" of the Lozovsky district. Convicted by the Special Council of the NKVD of the USSR on March 31, 1942. Shot on May 12, 1942. Rehabilitated by the conclusion of the Prosecutor's Office of the Pavlodar region of April 21, 1989.

**Dick Peter Jacob.** Born in 1867 in the village of Kodagai, Perekop district, Taurida province, German. He was arrested on September 2, 1937, on the day of his arrest he was a collective farmer of the collective farm "Iskra" of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 23, 1937. Shot on October 31, 1937. Rehabilitated by the decision of the 5th of the Presidium of the Pavlodar Regional Court of October 19, 1960.

**Enns Heinrich Abram** (#1145565). Born in 1895 in the village of Marinovka, Yekaterinoslav district, Yekaterinoslav province, German. He was arrested on October 7, 1937, on the day of his arrest he was a veterinary orderly of the collective farm "New Life" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on December 29, 1937. Shot on November 2, 1937 (before the decision of the troika). Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of June 2, 1960.

**Enns Jacob Gerhard** (#532743). Born in 1897 in the village of Kopkari, Yevpatoria district, Taurida province, German. He was arrested on November 2, 1942, on the day of his arrest he was the chairman of the collective farm named after Engels in the Lozovsky district. Convicted by the Pavlodar Regional Court on January 23, 1943 under Articles 58-2, 58-7, 58-10, Part 2, 58-11 of the Criminal Code of the RSFSR. Rehabilitated by the Decree of the Presidium of the Supreme Court of the Kazakh SSR of March 19, 1990.

**Enns Peter Peter** (#228528). Born in 1873 in the village of Schoenhorst (Vodyanaya), Yekaterinoslav district, Yekaterinoslav province, German. He was arrested on October 15, 1937, on the day of his arrest he was a veterinary orderly at the Frunze collective farm in the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Epp Heinrich Heinrich** (#1144217). Born in 1900 in the village of Schoenhorst (Vodyanaya), Yekaterinoslav district, Yekaterinoslav province, German. He was arrested on February 20, 1938, on the day of his arrest he was a commissioner for livestock procurement at the Workers' Party of the People's Commissariat of Internal Affairs of the USSR. Convicted by the two of the NKVD and the Prosecutor's Office of the USSR on August 29, 1938. Shot on September 29, 1938. Rehabilitated by the conclusion of the Military Prosecutor's Office of the Turkestan Military District of July 27, 1989.

**Fast Abram Abram** (#1144146). Born in 1879 in the village of Sparrau, Berdyansk district, Taurida province, German. On the day of his arrest, he was the chairman of the Raevsky village council of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 9, 1937. Shot on October 28, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of August 23, 1961.

**Fast Nikolay Peter.** Born in 1906 in the village of Waldheim (Lesnoje), Berdyansk district, Taurida province, German. He was arrested on January 16, 1942, on the day of his arrest he was the head of the Borisov incomplete secondary school of the Lozovsky district. Convicted by the Pavlodar Regional Court on June 20, 1942, under Article 58-10, Part 2, 58-11 of the Criminal Code of the RSFSR. Rehabilitated by the Decree of the Presidium of the Supreme Court of the Kazakh SSR of July 25, 1966.

**Friesen Abram Nicholai.** Born in 1875 in the village of Krasnopol, Aleksandrovsy district, Yekaterinoslav province, German. He was arrested on August 22, 1937, on the day of his arrest he was a collective farmer of the collective farm "Iskra" of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 23, 1937. Shot on October 31, 1937. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of October 19, 1960.

**Funk Jacob Benjamin** (#1143084). Born in 1900 in the village of Waldheim, Berdyansk district, Taurida province, German. He was arrested on August 20, 1937, on the day of his arrest he was the head of the farm of the collective farm named after Telman in the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Funk Johann Peter** (#1580517). Born in 1874 in the village of Waldheim (Lesnoje), Berdyansk district, Taurida province, German. He was arrested on September 8, 1937, on the day of his arrest he was a collective farmer of the collective farm named after Telman in the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Giesbrecht Gerhard Kornelius.** Born in 1892 in the village of Steinau, Yekaterinoslav province, German. On the day of his arrest, he was a carter of the state farm "Jolkuduk" of the Kaganovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 15, 1938. Shot on March 6, 1938. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of February 15, 1957.

**Giesbrecht Kornelius Kornelius** (#1143027). Born in 1899 in the village of Liebenau, Berdyansk district, Taurida province, German. He was arrested on November 5, 1937, on the day of his arrest he was a collective farmer of the collective farm named after Dimitrov in the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 20, 1937. Shot on November 28, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of December 10, 1960.

**Goertz David Peter** (#1144807). Born in 1897 in the village of Rudnerweide, Berdyansk district, Taurida province, German. He was arrested on November 5, 1937,

on the day of his arrest he was a cattle breeder-orderly of the collective farm "Iskra" of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 20, 1937. Shot on November 28, 1937. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of June 2, 1960.

**Goerzen Abram Johann.** Born in 1887 in the village of Fuerstenwerder, Berdyansk district, Taurida province, German. He was arrested on November 1, 1937, on the day of his arrest he was the chairman of the collective farm "Proletariy" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 11, 1938. Rehabilitated by the conclusion of the Military Prosecutor's Office of the Central Asian Military District of March 15, 1989.

**Goerzen Isaac Franz.** Born in 1904 in the village of Sofiyivka, Aleksandrovsky district, Yekaterinoslav province, German. Arrested on October 31, 1937, on the day of his arrest he was an accountant of the Shcherbaktinskaya MTS of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 27, 1937. Shot on December 4, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of April 21, 1958.

**Goerzen Jacob Abram.** Born in 1883 in the city of Armavir, Yekaterinodar district, Kuban region, German. He was arrested on October 21, 1937, on the day of his arrest he was a collective farmer of the collective farm "New Life" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on December 29, 1937. Shot on January 2, 1938. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of June 2, 1960.

**Goerzen Peter Kornelius.** Born in 1902 in the village of Chak-Mak, Perekop district, Taurida province, German. He was arrested on November 6, 1937, on the day of his arrest he was a blacksmith at the Krasin collective farm, Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 11, 1938. Rehabilitated by the Conclusion of the Military Prosecutor's Office of the Central Asian Military District of March 15, 1989.

**Gossen Isaak Isaak** (#1142542). Born in 1895 in the Berdyansk district of the Taurida province, German. He was arrested on September 25, 1937, on the day of his arrest he was the chairman of the collective farm named after Mirzoyan in the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 9, 1937. Shot on October 28, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of August 23, 1961.

**Gossen Johann Kornelius.** Born in 1912 in the village of Natashino, Uspensky district, German. He was arrested on March 6, 1942, on the day of his arrest he was the chairman of the Krasin collective farm in the Lozovsky district. Convicted by the Pavlodar Regional Court on June 20, 1942 under Articles 58-10 Part 2, 58-11 of the Criminal Code of the RSFSR. Rehabilitated by the Decree of the Presidium of the Supreme Court of the Kazakh SSR of July 25, 1966.

**Gossen Kornelius Kornelius** (#1229908). Born in 1894 in the village of Bekbulachi, Perekop district, Taurida province, German. He was arrested on November 24, 1937, on the day of his arrest he was a representative of the Maxime-Gorky district plenzagotkontora. Convicted by the troika of the NKVD in the East Kazakhstan region on December 7, 1937. Shot on December 30, 1937. Rehabilitated by the conclusion of the Prosecutor's Office of the Pavlodar region of February 6, 1990.

**Gossen Peter Peter**. Born in 1889 in the village of Blumenthal, Berdyansk district, Taurida province, German. He was arrested on September 25, 1937, on the day of his arrest he was a seller of the Raevsky rural consumer society of the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 9, 1937. Shot on October 28, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of August 23, 1961.

**Hamm Franz Martin**. Born in 1884 in the village of Repinau, Berdyansk district, Taurida province, German. He was arrested on November 1, 1937, on the day of his arrest he was a saddler of the collective farm "Proletariy" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 11, 1938. Rehabilitated by the conclusion of the Military Prosecutor's Office of the Central Asian Military District of March 15, 1989.

**Hamm Jacob Martin**. Born in 1898 in the village of Repinau, Berdyansk district, Taurida province, German. He was arrested on November 8, 1937, on the day of his arrest he was a collective farmer of the collective farm "Proletariy" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 11, 1938. Rehabilitated by the conclusion of the Military Prosecutor's Office of the Central Asian Military District of March 15, 1989.

**Harder Peter Peter**. Born in 1888 in the village of Lindenau, Berdyansk district, Taurida province, German. Arrested on September 1, 1937, on the day of his arrest he was a collective farmer of the collective farm "Fort-Shrit" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan 3rd region on November 22, 1937. Shot on December 4, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of March 10, 1958.

**Heidebrecht Heinrich Heinrich**. Born in 1901 in the village of Lindenau, Berdyansk district, Taurida province, German. He was arrested on November 24, 1937, on the day of his arrest he was the foreman of the collective farm "Fort-Shrit" of the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on December 7, 1937. Shot on December 30, 1937. Rehabilitated by the conclusion of the Prosecutor's Office of the Pavlodar region of February 6, 1990.

**Heinrichs Heinrich Dietrich** (#1144076). Born in 1881 in the Berdyansk district of the Taurida province, German. He was arrested on July 28, 1938, on the day of his arrest he was a cattle breeder at the Mirzoyan collective farm in the Zurupinskij district. Convicted by the troika of the NKVD in the Pavlodar region on September 25, 1938.

Rehabilitated by the conclusion of the Military Prosecutor's Office of the Central Asian Military District of April 13, 1989.

**Hildebrant Isaac Johann** (#1143861). Born in 1912 in the village of Sofieyevka, Shcherbaktinsky district, German. Arrested on October 11, 1942, on the day of his arrest he was a tractor driver of the collective farm "Iskra" in the Zurupinskij district. Convicted by the Pavlodar Regional Court on December 15, 1942 under Articles 58-10 Part 2, 58-14 of the Criminal Code of the RSFSR. Rehabilitated by the Decree of the Presidium of the Supreme Court of the Kazakh SSR of January 9, 1970.

**Hildebrant Jacob Johann** (#1143822). Born in 1874 in the village of Vodyanoye, Verkhnedneprovsky district, Yekaterinoslavsk province, German. Arrested on November 23, 1936, on the day of his arrest he was a veterinary orderly at the Dimitrov collective farm in the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on August 18, 1937. Shot on August 26, 1937. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of June 26, 1963.

**Hildebrant Johann Johann** (#1143860?). Born in 1905 in the village of Vodyanoye, Verkhnedneprovsky district, Yekaterinoslav province, German. He was arrested on June 19, 1942, on the day of his arrest he was a tractor driver of the collective farm "Iskra" of the Zurupinskij district. Convicted by the Pavlodar Regional Court on December 15, 1942 under Articles 58-10 Part 2, 58-14 of the Criminal Code of the RSFSR. Rehabilitated by the decision of the 4th of the Presidium of the Supreme Court of the Kazakh SSR of January 9, 1970.

**Isaak Gerhard Peter** (#428053). Born in 1873 (1878) in the village of Rosenort, (Sagradovka), Kherson province, German. On the day of his arrest, he was a shoemaker, lived in the state farm "Jolkuduk" of the Kaganovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 15, 1938. Shot on March 6, 1938. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of February 15, 1957.

**Isaak Peter Gerhard** (#1243394). Born in 1904 in the village of Rosenort, (Sagradovka), Kherson province, German. On the day of his arrest, he was a shoemaker, lived in the state farm "Jolkuduk" of the Kaganovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on February 15, 1938. Shot on March 6, 1938. Rehabilitated by the decision of the Presidium of the Pavlodar Regional Court of February 15, 1957.

**Janz Jacob Abram** (#731798). Born in 1906 in the Berdyansk district of the Taurida province, German. Arrested on September 3, 1937, on the day of his arrest he was an accountant of the collective farm named after Mirzoyan in the Zurupinskij district. Convicted by the troika of the NKVD in the East Kazakhstan region on October 9, 1937. Shot on October 28, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of August 23, 1961.



**Janzen Heinrich Jacob** (#1344136). Born in 1868 in the village of Schar dau, Berdyansk district, Taurida province, German. He was arrested on October 10, 1937, on the day of his arrest he was a watchman of the collective farm named after Telman in the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Klassen David Johann** (#1538675). Born in 1914 in the village of Borosovka (Gnadental), Lozovsky district, German. He was arrested on January 16, 1942, on the day of his arrest he was the driver of the collective farm named after Engels in the Lozovsky district. Convicted by the Pavlodar Regional Court on July 20, 1942 under Articles 58-10 Part 2, 58-11 of the Criminal Code of the RSFSR. Rehabilitated by the Decree of the Presidium of the Supreme Court of the Kazakh SSR of July 25, 1966.

**Klassen David Johann**. Born in 1890 in the village of Mazaevka, Don Army Region, German. He was arrested on September 22, 1937, on the day of his arrest he was the chairman of the collective farm named after Uritsky, Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Klassen Peter Johann**. Born in 1907 in the village of Chistopol, Lozovsky district, German. He was arrested on August 9, 1937, on the day of his arrest he was a blacksmith at the Frunze collective farm in the Lozovsky district. Convicted by the troika of the NKVD in the East Kazakhstan region on November 6, 1937. Shot on November 12, 1937. Rehabilitated by the decision of the Military Tribunal of the Turkestan Military District of September 28, 1963.

**Koop Abram Abram** (#73167). Born in 1884 in the village of Hamberg, Berdyansk district, Taurida province, German. Arrested on September 2, 1937, on the day of his arrest he was the chairman of the collective farm named after Dimitrov in the Zurupinskij district.
